1. Each of the awards may be given annually, but should be given only when merited.
2. The fiscal year of LARW will be the dates used to determine eligibility for any award.
3. Nominations forms will be e-mailed to the membership by no later than October 1 and distributed at the October Membership Meeting.
4. Nominations must be received by the Awards committee by no later than November 1.
5. Ballots with copies of the nominations forms will be distributed by e-mail and in person at the November Membership Meeting.
6. Deadline for receiving ballots from members will be December 1, and all ballots should be mailed to LARW PO Box or e-mailed to the President of LARW.
7. Executive Board will meet to count ballots by no later than December 10<sup>th</sup>.
8. Recipients of awards will be notified by the Board by no later than December 15<sup>th</sup>.
9. Recognition of recipients will be held at the December Membership Meeting. Recognition will be in the form of a framed certificate.

Additionally, LARW will award a **Membership Recruitment Award** to the member who recruited the most new members for the period January 1 through December 1 of each year. Recognitions of the recipient of the Membership Recruitment Award will be held at the December Membership Meeting. Recognition will be in the form of a framed certificate or as may be determined by the Executive Board.
